

How to design a policy influence plan?

Toolkit N°5

Who should we work with. Define actors and alliances

This toolkit is part of a series addressing the various components of a public policy influence plan.

Once the influence objectives have been established, the organization will be able to move towards the third step: it is necessary to identify the involved stakeholders with those objectives and, according to their power and interests, think about possible alliances among them.

For this, two basic questions may be asked:

- Who will be allies in the changes that are sought to be made?
- Who will block the proposed objectives?

To answer these questions, it is useful to make an a stakeholder’s map or analysis.



Useful Tool

Stakeholder's map or analysis	
<p>It consists in clearly identifying all the involved stakeholders that have interests and / or resources that can affect or be affected by the changes promoted by the organization.</p>	
Advantages	<ul style="list-style-type: none"> • It allows to detect potential allies and opponents as well as stakeholders that share interests but who are not aligned with the proposals of the organizations, and stakeholders who do not know much about the issue, but who support the organization's initiatives in general. • It reflects the power level of each stakeholder according to their resources and the needs and interests of the interested parties in the change (Weaving global networks, 2006).
To take into account	<p>Think about those stakeholders with whom different works have been carried out on other occasions.</p> <p>It is convenient to identify those stakeholders who have real capacity for decision making and carrying out changes.</p> <p>Try to be as specific as possible in the definition of the stakeholder, try to identify concrete people within involved institutions or agencies (for example, think about ministers, advisors, political party leaders or journalists and not about ministries or organizations).</p> <p>To carry out the stakeholder analysis, the force field analysis can be used¹: it is highly probable that some stakeholders who are in favor or against the change be strongly involved with interests and resources of the other identified stakeholders (Weaving global networks, 2006).</p>
How is it implemented?	<p>In Figure 1 we present an example of the information that should be specified when drafting a stakeholder's map.</p> <ol style="list-style-type: none"> 1) Point out the levels in which each stakeholder operates and makes decisions (global, regional, national, and local). 2) List the involved actors, according to the levels previously identified. 3) Reflect about the interests that make stakeholders relevant and important in relation to the organization's objective. 4) Identify the resources that the stakeholders have (from material resources to knowledge, information access, contacts, etc). Finally, think about the resources that may give us an idea of the level of power of each stakeholder in order to drive or block the change that the organization wants to carry out. According to Mintzberg (1992), power sources may be very diverse (legal authority, knowledge, moral authority, technical skills, etc.) and they grow as they become more essential and irreplaceable for all the involved stakeholders (Weaving global networks, 2006). Besides, power can be classified into levels: high, medium, low.



Recognizing stakeholders on the web

Apart from being useful to communication², web 2.0 tools can also be used to obtain information about other stakeholders working on the issues related to the proposed influence objectives. Involving and interacting in virtual spaces where there are discussions and sharing information interesting for the organization, actively following web sites or social media accounts of decision-makers and other relevant stakeholders, and establishing virtual communication channels are some of the strategies that can contribute to creating a more complete stakeholder's map. Some relevant 2.0 tools are: Facebook, Twitter, LinkedIn, virtual fora or blogs.

To recognize the power that each of the identified stakeholders has and how they are aligned or not with the organization's influence objective, it is also valuable to use the following diagram:

Figure 2. Diagram of stakeholders in favor or against the influence objective

Probably, the time and available resources that the organization has may not be sufficient to develop the links with all the stakeholders identified in the map. Therefore, it is fundamental to prioritize the work with those stakeholders that are more important in relation to the objective (either because they have more power or skills to provide a greater possibility of reaching the organizations' objective) or to those that are more accessible in order to establish contacts and concrete the effort in actions that involve them.


Finally, once the relevant stakeholders for the objectives are chosen, it will be possible to define the strategy to follow with each of the actors involved (available in **Toolkit N°7: How to carry out the proposal. Define strategies and actions**) and prioritize those that need to be highly emphasized from the communicational point of view (available in **Toolkit N°8: What will be the message. Design the communication plan**).


